Nominations will be presented to the SAIL Board of Directors at the SAIL Board Meeting as per article 7.4.4 of the Constitution and Bylaws.

7.4 Nominations to the Board

- 7.4.1 An Organization must have a membership in good standing in SAIL in order to nominate candidates to the Board.
- 7.4.2 An Individual must have a membership in good standing in SAIL in order to nominate candidates for the Board.
- 7.4.3 Active Directors or candidates for election are not eligible to nominate other candidates.
- 7.4.4 **Any nominations for the Board must be presented to the Board, or a committee of the Board established to receive nominations, not less than (20) days prior to the Annual General meeting. A slate of candidates will be presented for a vote by the membership at the Annual General Meeting.**

NOMINATION CRITERIA FOR SAIL BOARD MEMBERS (applies to all positions):

- **Must be *Regular Member - Individual* at the time of the AGM. If a candidate is not already a *Regular Member – Individual* of SAIL, they must include a membership application and \$25.00 membership fee with their nomination forms;**
- Willingness to make a time commitment;
- Respect for the cultural diversity of the province;
- Knowledge of the heritage language community;
- Prepared to work for the heritage language community as a whole;
- Ability to exhibit leadership;
- Commitment to attend SAIL's membership and board meetings;
- Prepared to work on SAIL's internal committees.
